[certified e-mail]: alberto.ferrari.milano.pecavvocati.it), registered with the ICC List of Assistants to Counsel, both with domicile in via Ceradini 16, 20129, MILAN, Italy, being the former appointed as legal representative pursuant power of attorney and the latter as associate counsel pursuant designation both on 26th August 2019, 22nd November 2019, 18th December 2019 and 20th August 2020;

On 26th August 2019 the tenth witness on the list attached to the information deed – designated with n. W-10 – decided to join the other seven

injured persons and to grant power of attorney to the undersigned counsels to seek participation and representation in this proceeding.

The numbering criteria for the injured persons and the witnesses therefore change so that witness W-10 turn to be victim V-8. Unvaried remains the numbering of all the others persons involved as either injured persons or witnesses.

On 22nd November 2019 and on 18th December 2019 two new injured persons decided to join the denounce before the International Criminal Court. They will be indicated henceforth as Miss V-9 and Mr V-10.

Miss V-9 during the travel was pregnant.

On 20th August 2020 also the twenty-third witness on the list attached to the information deed – designated with n. W-23 – decided to join the other injured persons and to grant power of attorney to the undersigned counsels to seek participation and representation in this proceeding. His designation number then turns from W-23 to V-11.

Miss V-9 and Mr V-8, V-10 and V-11 confirm all statements of the facts exposed in the introductory deed drafted on behalf of the other seven injured persons and joins the following

RESPECTFUL REQUEST:

- that the Office of the Prosecutor initiate an investigation into the situation of Mali, Burkina Faso, Niger, Libya and Italy for the purpose of charging the persons responsible of the commission of the following crimes against humanity: enslavement, imprisonment or other severe deprivation of physical liberty in violation of fundamental rules of the international law, murder, tor-

ture and other inhumane acts of a similar character intentionally causing great suffering, or serious injury to body or to mental or physical health;

- with the express reserve to submit application for participation to the relevant Chamber pursuant to rule 89.
